## Amendment to Resolution Regarding Pay Codes Included as Pensionable Income

In accordance with the provisions of the California Public Employees' Pension Reform Act of 2012 (AB340), the Board of Retirement for the Tulare County Employees' Retirement Association (TCERA) determined on November 7, 2012 those Tulare County pay codes that are to be included in "compensation earnable" for the calculation of retirement benefits paid by TCERA. The TCERA Board of Retirement is aware that new pay codes have been approved by Tulare County and that certain existing pay codes were not included in the original resolution. The existing pay codes that were not included in the original resolution were inadvertently omitted because they were classified as regular pay by the County of Tulare (County). The pay codes submitted for review included only those codes classified as additional pay. In addition, those codes used in conjunction with Workers Compensation pay were also inadvertently omitted from the original list submitted by the County. The TCERA Board of Retirement takes this action to amend the list of pay codes included in the original resolution and the previous amendment adopted October 14, 2015. The following pay codes will be included or excluded as part of compensation earnable for the purpose of calculation pension benefits for all tiers pursuant to Government Code §31461 and Government Code §7522.34:
